



**NCAA ATTESTATION RELATING  
TO CRIMINAL AND STUDENT CONDUCT MATTERS**

The NCAA requires all incoming and continuing student-athletes at the University of Kansas (“KU”) to provide information to KU relating to their personal conduct. The student-athlete must complete this form truthfully and thoroughly, as failure to do so may result in ineligibility for financial aid, practice, and competition. In completing this document, please use the following definitions:

**Interpersonal Violence:** Violence or attempted violence that is predominantly caused due to a relationship (romantic, related-family members, etc.) between the victim and perpetrator, including, but not limited to, dating and domestic violence, harassment, and stalking.

**Sexual Violence:** Forcible and nonforcible sex offenses ranging from sexual harassment to sexual assault (i.e., verbal/physical sexual harassment, sexual exploitation, incest, or any form of non-consensual sexual contact, including, but not limited to, rape, statutory rape, indecent liberties with a child, and sexual exploitation).

**Other Acts of Violence:** Crimes including murder, manslaughter, aggravated assault, hate crimes, or any assault that employs the use of a deadly weapon, or causes serious bodily injury.
